# Accomplishments

## SAFETY AWARENESS DAY

Presidential Commission on Disabilities sponsored a Crosswalk Safety Awareness Day featuring Ms. Deborah Casadei, PennDot Public Information Officer via a Facebook Live session for the Clarion Borough and Clarion University of Pennsylvania. The Commission conducted their annual safety walks, one in fall and one in spring, to identity areas that may be unsafe or to make recommendation to improve a certain area.

#### SPEAKERS AND PANEL DISCUSSIONS


