DOMESTIC VIOLENCE AND ABUSE AWARENESS DAY

The Presidential Commission on Sexual Harassment hosted the second annual Domestic Violence and Abuse Awareness Day in October. This event showcased original poetry by students, staff and faculty to advocate for the prevention of abuse of any kind and for the recovery of the survivors. Photography by Chad Thomas depicted students, staff and faculty representing financial, emotional and physical abuse. A resource fair provided local resources for recovery from the trauma of abuse.

DENIM DAY

The campus participated in Denim Day in April. For the past 20 years, Peace Over Violence has marked April as Sexual Assault Awareness Month through its Denim Day campaign. The campaign began after a ruling by the Italian Supreme Court that overturned a rape conviction. The justices asserted that the victim, who was wearing tight jeans, must have helped the rapist remove her jeans, thereby implying consent. The following day, women in the Italian Parliament, in solidarity with the victim, wore jeans to work. Denim Day has become a symbol of protest against destructive attitudes about sexual harassment, abuse, assault and rape. The commission partnered with sororities to provide information about Denim Day and handed out ribbons and buttons for individuals to wear on Denim Day.

SAFE ZONE TRAINING

In the spring semester, the Presidential Commission on LGBT+ Concerns offered two Safe Zone trainings to faculty and staff, resulting in the addition of 26 new Safe Zone spaces, for a total of 59. Safe Zone trainings teach about LGBTQ+ identities, gender and sexuality, and examine prejudice, assumptions and privilege. "Safe Zone" or "Safe Zone Trained" placards indicate that the person displaying the sticker has gone through training and are open to talking about and being supportive of LGBTQ (lesbian, gay, bisexual, transgender and queer/ questioning) individuals and identities. More Safe Zone trainings are planned for 2019-2020 academic year.

The commission obtained a professional tablecloth with Clarion University logo. This is a useful tool to highlight Clarion University's presence at major events and help in student recruitment at conferences and job fairs.

As part of Holocaust Remembrance activities, the commission invited Redbank Valley Schools teacher and Clarion alumnus Dr. Joseph Harmon to talk about World War II concentration camps. The next day, with rare footage and stunning dramatization, the Holocaust documentary "Who Will Write Our History?" was shown.

The commission hosted 16 minority alumni who attended Clarion University between 1963 and 1968. The alumni were pleased to know about the role of the commission in helping to promote racial equity.

The commission attended the AACU conference, "Diversity and Equity Infusion." Members recruited students to Clarion and networked with other faculty to highlight the ways Clarion promotes racial equity on campus. They

What they found (and research has shown) is that mandatory trainings are not effective. The university applied for a grant that paid faculty a stipend to take part in training, which has since transformed into a summer institute.

Commission members presented a poster, "Institutionalizing

The commission authored a CU professional development grant to conduct a one-day workshop at on racial equity and inclusion. The workshop will be repeated during the 2019-2020 academic year. A racial equity resource website was developed for CU students and employees. Members created "This Is Our Neighborhood" flyers to create awareness on common racial equity and discrimination issues. The commission is reviewing and revising departmental policies on racial equity.

The commission purchased DVDs of documentaries "White like Me," "Reveal Moment," and "Broken on All Sides." They are available to anyone interested in screening the movies on campus.
