


### DENIM DAY


### 21-DAY RACIAL EQUITY CHALLENGE

In the fall, the commission organized a 21-Day Racial Equity Challenge from the Michigan League of Public Policy (found *here*). The challenge saw participation from over 40 members of faculty and staff during September, engaging via the website or through daily emails about the topics covered on the website. At the conclusion of the challenge, participants gathered for a Zoom discussion about racial equity and how the material within the challenge could best serve Clarion. We discussed how this challenge could provide a jumping off point for larger campus discussions, trainings and workshops. As a result of the response to this challenge, the Commission on Racial Equity formed a sub-committee on training to explore future options.

### CONSIDERING RACE

The Presidential Commission on Racial Equity hosted "Clarion Conversations: Considering Race," which was postponed last year due to the pandemic. The grant-funded event featured four workshops (three for students, one for faculty) held April 14 and 15. Facilitated by

Dr. Kathleen Gray and Dr. Ronald Gray, "Making Space: Building Inclusive Community on Campus and Beyond" featured discussions that explored how race and racism shape our lives and impact our communities. Participants – 260



students and 40 faculty – learned strategies for navigating difficult conversations about race and strengthened the skills needed to create a more inclusive campus community.

### NOT JUST A GAME: RACE, POWER AND AMERICAN SPORTS


As part of "Clarion Conversations: Considering Race," the Commission co-sponsored two viewings of the film "Not Just a Game: Race, Power, and American Sports." In the film, cultural historian David Zirin is interviewed by Sut Jhally to examine the ways sports culture has worked to both reproduce and challenge the wider culture's dominant ideas about race and racial difference. Participants engaged in a fruitful discussion about race and sports after the conclusion of the film.

### PATRICE D'ERAMO TALK

The commission and Clarion Consulting Center co-sponsored "Being a Successful Female in a

Male-Dominated Industry" by Clarion graduate Patrice D'Eramo. She discussed her experiences working in marketing and communications.





#### WEBSITE RESOURCES

The commission continues to update its web page to provide several resources for faculty, staff, and students at the university to talk about race. Resources include books and articles, films, links to TED talks addressing issues of race and racial inequality, websites providing information about local and regional government alliances on race and equity, links to tools designed to support individuals and groups working to achieve racial equity, and podcasts focusing on issues relating to race. *Mission:* The mission of the Presidential Commission on Sustainability is to advocate issues of sustainability both on and off campus by coordinating and promoting educational opportunities and programming through collaboration with the various stakeholders toward the goal of reducing the university and larger community's consumption of natural resources to a sustainable level.


At the end of the fall 2020 semester, the commission created and shared its second Sustainability Newsletter. With the theme "Giving Back," the newsletter included tips on sustainable investments, supporting sustainability initiatives and shopping sustainably.

At the start of the spring 2021 semester, the commission formed three working groups: Paper Reduction Initiatives, Commission Webpage and Earth Week event planning. Paper Reduction Initiatives will identify mechanisms for reducing paper use/waste on campus. This is particularly relevant with the return of face-to-face operations this fall. The Commission Webpage team seeks to make the webpage more informative, interactive and useful, relative to surveying and collecting sustainability data.

The Earth Week Planning team focused on virtual events for Earth Week 2021. Virtual Earth Day speaker Dr. Maria Dillard, acting director of disaster and failure studies of the National Institute of Standards and Technology, presented "The

Racial Inequality of Environmental Hazards." She drew on existing research on natural and technological hazards as well as climate change and cited examples of differential impacts and outcomes across populations.

During Earth Week, the commission initiated the Small Choices, Big Impacts campaign which encouraged university members to make conscious choices during Earth Week (and beyond) and to share on social media using #Green-Clarion. Suggestions included: Meatless Monday – Reduce your meat consumption; Transportation Tuesday – Use an alternative to your personal vehicle (walk, bike, carpool, public transportation); Water Wednesday – Minimize water waste; Thrifty Thursday – Set a goal for one or more of the 5 R's (Refuse, Reduce, Reuse, Re-purpose, then Recycle); Fresh-air Friday – Spend time in nature.

The PCVM was established by President Dale-Elizabeth Pehrsson in September 2020 after years of foundational work by multiple individuals. An initial meeting of interested faculty, staff and administrators was called Oct. 27 via Zoom by Amy Salsgiver, director of Social Equity, on October 27 via Zoom, who subsequently sent out a call for nominations and self-nominations from this group for the core administrative positions on the PCVM.

Salsgiver then called for an organizational meeting with the elected officers that took place Dec. 8, where she explained the Presidential Commission structure and basic expectations for the PCVM in the spring.

#### SPRING 2021

The PCVM held its first formal meeting Feb. 10, 2021, via Zoom. This was generally an introductory meeting. Members agreed to:

- solicit a student member(s) this semester,
- ensure that we sponsor or generate an activity for Veteran's Day in November 2021,
- ask for data on current veterans at the University,
- work to develop a relationship with the ROTC and the Venango Campus Veteran's Club, and
- ensure that Western PA integration plans include a focus on veterans—especially the need for a full-time Director for Veterans Affairs.

The PCVM held its second meeting March 10, 2021, via Zoom. Jim Reisinger was unanimously nominated to serve as a student member of PCVM and was subsequently appointed to the commission by President Pehrsson. Members reviewed and discussed a report on the activities of Venango Campus Veteran's Club. PCVM member Josh Domitrovich actively advocates for veterans and has advocated in a relevant integration work group for a full-time director of veterans affairs. PCVM adopted two additional goals:

- Stand up the Clarion Student Veteran's Association.
- Change second bullet to: Investigate potential Green Zone training for faculty, staff and administration.

Actions taken at PCVM's third and final meeting of the year, held April 28, included:

- Incentivize new student membership and promote the commission by presenting an annual Student of the Year award. The initial award will be presented in spring 2022.
- Determine a speaker for Veteran's Day.
- Develop and distribute a survey to student veterans and ROTC students.
- Adopted a final goal to follow-up on knowledge and use of Clarion University's M-grade for veterans who are deployed.
