1. Approval of Proposed Clarion University Policy on Protection and Supervision of Minors on Campus – See Attachment A. – Dr. Jocelind Gant, presenter

<u>Background</u> – Board of Governors Policy 2014-01-A, Protection of Minors, mandates that each Pennsylvania State System of Higher Education (State System) University establishes and implements policies and procedures that promote the safety and security of children (under the age of 18) in all programs on campus and University sponsored programs off campus. Pursuant to the Policy, the University is required to maintain a registry of individuals who have direct contact, interact with, treat, supervise, chaperone or otherwise oversee minors and of programs for minors. Programs for minors are required to address, among other things, safety and security training, staffing ratios, transportation and housing requirements.

In addition, the Policy makes clear that University employees, volunteers and some contractors are mandated reporters who are required to report child abuse.

BOG Policy 2014-01-A further mandates that the University policy sets forth criminal background screening policies and procedures in accordance with applicable procedures, standards and guidelines issued by the State System Chancellor. In addition, the Pennsylvania legislature amended the Child Protective Services Law (Act 153 of 2014), with amendments taking effect on December 31, 2014, to require State System employees and volunteers who have direct contact with children to obtain clearance checks.

RESOLVED, that the Council of Trustees, Clarion University, approve the proposed policy on *Protection and Supervision of Minors*, as submitted by the President on this 23<sup>rd</sup> day of April, 2015.
