

Clarion University Coronavirus Response Update Coronavirus, Aid, Relief and Economic Security (CARES) Act Higher Education Emergency Relief Fund (HEERF) May 13, 2020

Dear Clarion Students,

Clarion University has received funds from the CARES Act - Higher Education Emergency Relief Fund. Following the U.S. Department of Education's guidance, Clarion University is awarding \$550 grants to all eligible students for expenses related to the disruption of campus operations due to COVID-19 as of March 13, 2020, the date of the President's Proclamation, "Declaring a National Emergency Concerning the Novel Coronavirus Disease (COVID-19) outbreak." These funds will be paid to students via direct deposit or check, depending on which payment method you have on file with Student Financial Services. We strongly encourage all students to use direct deposit. Please see FAQ below.

Refunds will be processed beginning as early as May 15, 2020, and will continue until all funds are disbursed as per the two phases below:

PHASE 1:

All eligible students who have filed a 2019-2020 FAFSA and were taking credits in a face-to-face course on campus will receive a \$550 grant.

PHASE 2:

Students who did not initially file a 2019-2020 FAFSA. For those non-filers, they can still complete a FAFSA at https://studentaid.gov/h/apply-for-aid and possibly qualify. New FAFSAs will be reviewed and grants will be processed on a weekly basis. Clarion's school code is 003318. Note however, that the deadline to file a 2019-2020 FAFSA for consideration of the CARES Grant is **June 15, 2020.** We are not allowed to accept any new FAFSA's for the CARES Act beyond this date.

ELIGIBILITY RULES

The U.S. Department of Education has indicated the following guidance and rules on who can receive CARES Act funding. Below are those eligibility requirements for Clarion students.

ELIGIBLE STUDENTS ARE THE FOLLOWING:

- Only students who are or could be eligible to participate in programs under Section 484 in Title IV of the Higher Education Act of 1965, as amended (HEA), may receive emergency financial aid grants.
- Students who filed a 2019-2020 FAFSA
- Students enrolled in either the Spring 2020 semester and/or 7W2 session
- Students who meet Financial Aid Satisfactory Academic Progress for 2019-2020

INELIGIBLE STUDENTS ARE THE FOLLOWING:

- Students enrolled exclusively in an online program on March 13, 2020*
- Students enrolled exclusively in the Spring 2020 7W1 session
- Students enrolled exclusively in online courses for the Spring 2020 semester. Face-to-face credits for the 7W1 session are excluded.
- Students enrolled exclusively in a certificate program
- Non-degree seeking students
- Dual enrolled students
- Students auditing a course
- International students
- DACA students
- ESOL students

HOW DO I ENSURE A TIMELY CASH DISBURSEMENT?

Refunds for students with direct deposit will be processed more quickly than those requiring a paper check. Direct deposit is encouraged, as it is the fastest and most secure option for receiving your CARES Grant. Grants are available in your bank account within 2-3 business days after processing, thereby eliminating mail delays and the chance of a lost or stolen check. Instructions for setting up direct deposit are available here. If you elect not to set up direct deposit, any grants issued will be mailed to your permanent address and may take 7-10 business days to arrive once the checks are printed and mailed via the U.S. Postal Service. Please login to your **MyClarion Student Center** and verify and/or update your permanent address to avoid lost or returned checks.
